
















OUR OPERATIONS TEAM

To our dear Volunteers: your **dedication** and **compassion** are the **backbone** of our organization, and we couldn't do this work without you.








ABOUT US

The Asylum Seeker Support Trust (ASST) was founded in **1989** as the **Auckland Refugee Council Incorporated (ARCI)** and adopted its current trading name in 2015.

OUR MISSION

Our mission is to provide humanitarian support to asylum seekers in New Zealand. We offer essential services, with a focus on dignity, **inclusion**, and **empowerment**.

We currently support **2,155 clients**, ensuring they have access to basic necessities, community connections, and opportunities to **rebuild their lives**, addressing any challenges that arise along the way.



CLIENT SERVICES GROWTH

- We have expanded our Client Services team to meet the growing needs of asylum seekers arriving in Aotearoa. With 9 full-time staff members, our team now offers support in over 14 languages, ensuring comprehensive assistance for our diverse client base.
- We have rented a new office space in Mt Albert, it has a great location with excellent bus and train connections nearby.

ADVOCACY AND LEGAL SUPPORT

Collaborated with legal experts, academic, government and non-government bodies and community organisations to address challenges in the Refugee Status Determination process.

FUNDING AND PARTNERSHIPS

- Secured \$142,000 in funding from Foundation North, enabling us to continue providing essential services.
- Established a strong partnership with MBIE and funded \$500,000 for three social worker and manager
 position plus for hostel operational cost. We are hoping this new partnership with MBIE will be a
 benchmark for long term collaboration.
- JR McKenzie has funded an Impact Assessment Report of ASST, which is being completed. This document will **highlight the impact** of our work, what we do well and where we can improve. We'll share the report via email to all our stakeholders and on ASST website and social media platforms when it is completed.
- We received a new 2023 KIA, eight passenger seaters, funded by Foundation North and Hugo Charitable Trust, to replace our old and worn-out van.
- Kristin School students donated two Vegepod greenhouse to ASST as part of their community outreach
 initiative. This is helping our residents to grow their own fresh vegetables and herbs, and it promotes
 sustainability and therapeutic outcomes.

COMMUNITY ENGAGEMENT

- Successfully hosted our first community event in August 2024, offering new information and engagement opportunities for asylum seekers and the public.
- A Z00 trip was organized for 77 people, providing our clients and their families the opportunity to enjoy a day out with Nature. It also served as a chance for social interaction and connection.





- Monthly dinner for hostel residents (sponsored by Pearls of Island and Everybody Eats Onehunga branch), provides an opportunity for them to dine offsite and fosters social cohesion.
- We organised/facilitated a workshop for our clients on child safety laws in Aotearoa New Zealand. Speakers came from the Ministry of Education (MOE), Plunket Whānau Āwhina, and Neighborhood Support.
- We organised/facilitated another workshop for our clients on asylum seekers' entitlements and support services but also their responsibilities in Aotearoa New Zealand.



CINEMA TRIP

We had the privilege of taking **52 people** to the cinema during the school holidays, providing a special outing at a time when there is barely anything that they can afford as leisure for themselves and their children.



OPERATIONAL IMPROVEMENTS

- Improved hostel management, including repairs, cleaning, and the installation of new equipment to ensure a safe and welcoming environment.
- We hired a contractor to **manage our media efforts**, leading to a **rebranding of our website** and an **increase in social media engagement** by creating additional platforms. Our news and stories are now shared through **newsletters**, **podcasts**, **and YouTube**.
- ASST has replaced one of our older vehicles to ensure the safety of our staff and volunteers, as it had
 developed several issues. This new car will be essential for delivering food parcels, transporting clients,
 and managing various logistical tasks.
- We expanded the shed at the hostel to address **challenges staff** and **volunteers faced** in preparing food boxes during the **rainy season**.







OVERVIEW OF FINANCE PERFORMANCE

In 2024, ASST achieved financial stability through generous **donations**, successful **grant** applications, and diligent **budget** management, allowing us to maintain a strong financial position. This secure footing has enabled us to continue providing **high-level** support to those in need.

Looking ahead to 2025, our financial strategy will focus on diversifying funding sources, enhancing **donor** engagement, and securing additional long-term grants to ensure the **sustainability** of our programs.





Treasurer's Report for the Annual General Meeting

It is my pleasure to be able to report that 2023/2024 was our strongest financial year ever. Asylum Seekers Support Trust has been well supported financially by our funders and donors including JR McKenzie Trust, Foundation North, Lotteries, Cathro and Butland Trusts, Auckland Council, Hugh Green Foundation, Catholic Caring Foundation, the Hugo Charitable Trust, The Trusts Charitable Foundation, and The Wahine Fund (Ministry for Women).

In addition, ASST has received our first direct funding from the Ministry of Business, Innovation and Employment (MBIE) under a contract arrangement for our work with people seeking asylum. This significant income from MBIE has allowed us to expand our team and the assistance which we provide. The growth in staff numbers and the support we could give during the second half of the financial year to 30 June 2024 is referred to in the Annual Report. The board is very pleased to be in the position to be able in our accounting to allocate amounts to reserves. A sum of \$200,000 has been allocated to a long-term reserve so we have monies to close down operations in an orderly fashion for our clients and staff, should at some point our funding ever dry up. As well \$250,000 has been allocated to a client services reserves to allow us to reach more people in need. In our current financial year, the board has budgeted to spend \$80,000 of this reserve, in part because of a timing difference between when MBIE funds have been received and when some costs will be incurred, and primarily as we respond to the record number of people currently seeking asylum in Aotearoa.

The Audit of our Annual Accounts for the year ending 30 June 2024 is due to be completed in the second week of November, a little too late to be available for you at this AGM. At this point I have attached for your information the two key financial pages from the draft annual accounts, being the Statement of Financial Performance showing the income and expenses for the year and the Statement of Financial Position which sets out the net assets at the end of the financial year.

As soon as the Auditors have completed their Audit Report, the 2023/24 Annual Accounts will be uploaded, as in previous years, to Charities Services. These can then be viewed on their website, or ASST website, or alternatively you can contact ASST (email: secretary@asst.org.nz) and a copy will be provided when the audited accounts are available.

PROGRAMS AND SERVICES OVERVIEW



Emergency Housing

We run a hostel and a few other accommodations in the community, providing safe temporary housing to asylum seekers, helping them transition from a place of crisis to a place of stability.



Advocacy & Support

Our team worked tirelessly supporting asylum seekers throughout their asylum journey with Immigration NZ and the Courts (where applicable), and ensuring they receive fair treatment and access to their entitlements from essential services such as Legal Representation, WINZ, IRD, and the health and education sectors.







Food Assistance

ASST distributes around **130** vibrant and nutritious food boxes twice a week, providing essential support to approximately **500 to 600** people every Tuesday and Friday. With the dedicated efforts of our staff and volunteers, and the invaluable support of Kiwi Harvest and Fair Food, we ensure that no one goes hungry.



Warm for Winter Project

This initiative provided **270 blankets**, **150 pyjamas** and **60 heaters** for over **350 Clients** helping them cope with New Zealand's harsh winter conditions. This included **140 Children**.

PROPOSED LEGAL STRUCTURE CHANGE

The overarching goal of the Auckland Refugee Council Incorporated (ARCI), through the Asylum Seekers Support Trust, is to help create a New Zealand where Asylum Seekers and Refugees are **welcomed**, supported and **thriving**. This will continue as we **grow** and **develop** into the future. It is important to ensure that our organisation is **sustainable** and adaptable with the right **legal structures** in place to support our work.

CHANGE FROM INCORPORATED SOCIETY TO A CHARITABLE TRUST

With this in mind, ARCI is planning to transition from its current status as an **incorporated society to a charitable trust.** This would mean that the ARCI's constitution is replaced by a new trust deed. Both types of entities can achieve the same **goals**, however they have **administrative** and **governance** differences.

01. Clear Purpose

We continue to have a clearly defined mandate to support Asylum Seekers and Refugees in New Zealand, based on the existing purposes and objects of ARCI. We want to reassure you that switching to a charitable trust will have no impact on our purposes and objects, or the support we provide to our community. We would continue to hold our charitable status, registered under the Charities Act 2005.

03. Specialist Trustees

We would appoint trustees with diverse skills, expertise and passion to serve our community best. As part of the appointment process, the Board would be required to take into account the ability of any prospective appointees to represent Asylum Seekers and Refugees on the Board (including some through their lived experience or membership of the Asylum Seeker or Refugee community in New Zealand). The first trustees of the charitable trust would be the current Board members of the incorporated society.

02. Simplified Governance

A simpler structure of governance. While we currently have elected board members, we would transition to having appointed trustees. This would mean that we would no longer have any "members", and all decisions would be made by the appointed trustees. We understand the importance of representation and involvement of our stakeholders and would look at ways to include that in the new structure.

04. Reduced Administration

Greater freedom around when we have our annual meetings and the records we are required to keep, allowing us to focus on the more important things. We would still have reporting requirements as a charitable trust, including the requirement to publish annual financial information through Charities Services. We are working with our key funders and suppliers to ensure all our key agreements and assets are smoothly transitioned to the new charitable trust.

At the AGM, it is proposed that the members of ARCI vote on the following resolutions:



1-Change of Structure

to change the ARCI's legal structure from an incorporated society to a charitable trust;



2- Establish Charitable Trust

to authorise
ARCI's Board to
finalise the form
and content of
the charitable
trust and do all
things
necessary to
establish the
charitable trust:



3- Transfer of Assets

to transfer ARCI's
assets, liabilities,
undertakings and
obligations from the
incorporated society to
the new charitable trust
deed in accordance
with the requirement to
"direct the method of
disposal of funds" in
clause 23 of the
Constitution; and




4- Dissolution of ARCI

once the transfer is complete, to dissolve ARCI in accordance with clause 23 of the Constitution.

For the resolutions to pass, **75%** of the voting members of ARCI will need to vote in favour of the resolutions at the AGM. The resolutions will then need to be confirmed at a further special general meeting, not earlier than **30 days** after the AGM.




